


While under school jurisdict on, students are required to conduct themselves at all times in a manner that is in the best interest of the school and community. It is expected that students will:

- A. Conform to reasonable standards of speech, conduct, and dress and refrain from vulgar,obscene, and disrespect ul conduct directed toward staf and other students.
- B. Refrain from violat ng or impairing the rights of others, including physical abuse, sexual harassment, hazing, and conduct considered "bullying" as defined in state law and prohibited under School District policy.
- C. Refrain from conduct that deprives other students of an orderly atmosphere for learning.
- D. Refrain from knowingly possessing, handling, or transmit ng any object that can reasonably be considered a weapon.

Any weapon, look-a-like weapon, or contraband item found on a student, or on property under the possession or control of the student while on school grounds or at any school-sponsored event, will be conf scated immediately from the student by the appropriate administrator, school personnel, or adult in charge. Thereaf er, if required by law to be turned over to law enforcement authorit es, such weapon or contraband item will be surrendered to lawenforcement of cials. Some weapons (including all handguns) are mandated by law to be forfeited upon such conf scat on and surrendered to law enforcement personnel. k	Robbery is defined as the taking or at empting to take anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or by puting the victim in fear of immediate harm. Because some type of assault is an element of the crime of robbery, an assault should not be reported as a separate crime if it is performed in furtherance of the robbery. If an injury occurring during a robbery results in death, the crime should be listed as a homicide.
o \ . 7	A Forcible Sex of ense is any sexual act directed against another person, forcibly and/or against that person's will, or not forcibly or against the person's will where the vict m is incapable of giving consent. This definit on includes forcible rape, forcible sodomy, sexual assault with an object (to use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will where the vict m is incapable of giving consent because of his or her youth or because of his or her temporary or permanent mental or physical incapacity), and/or forcible fondling (child molest ng).

Weapons \	The violat on of laws prohibit ng any person, except law enforcement of cers or personnel authorized by school of cials, to carry on his or her person, while on any elementary or secondary school property, a knife with a blade over two inches long, a blackjack, a metal pipe or pole, f rearms, or any other type of weapon, device, or object that may be used to infict bodily injury or death. This category also includes carrying in a concealed manner a dirk, slingshot, metal knuckles, razor, or other deadly weapon usually used for the infict on of personal injury.

ATTENDANCE

- Students are required to bring writ en documentat on for absences within 5 days from the day they return from an absence. Absences may be submit ed via email to the school at endance derk this method is subject to verif cat on.
- The principal shall approve or disapprove absences in excess of 10 (5 for semester classes). A medical note or other documentat on will be required af er a student accumulates 10 absences (5 for the semester) in order to assist the principal in making that decision.
- Absences with no documentat on are automat cally considered unlawful.
- Students who accumulate 3 consecut ve unlawful absences or a total of 5 unlawful absences will be considered truant. Parents/guardians and students (12 years and older) will be contacted to develop a writ en At endance Intervent on Plan. Failure to part cipate and/or adhere to the plan will result in a referral to the District At endance Of ce and/or Family Court.

Tardy is defined as not being inside the appointed dassroom at the beginning of designated dass period start time. Students who are late to school shall be marked absent to dass when the entire dass is missed and marked tardy to the dass that is part ally missed. Unexcused/Unlawful tardies are considered a violation of the CSAL in that instruct on time is missed. Unexcused tardies and unlawful absences from individual dasses will be addressed in an At endance Intervent on Plan and may result in a referral to the District At endance Office or Family Court.

Criminal Conduct is defined as those act vities that result in violence to oneself, another person, or destruct on of property. These act ons pose a direct and serious threat to the safety of oneself or others on a school vehicle. Criminal conduct usually requires administrat ve act ons, which could result in the immediate removal of the student from school, the intervent on of law enforcement authorities, and/or act on by the Board of Trustees. Level III violations may lead to a student's immediate removal from the bus at the school or bus transportation of ice. Acts of criminal conduct may include, but are not limited to the following violations.

- Fight ng on the bus
- Physically abusing or hit ng another passenger
- Possessing, using, or distribut ng explosives and/or f reworks
- Carrying a weapon or any object that might be used as a weapon

A pupil may be suspended from riding the bus for one week for the first of ense, two weeks for the second of ense, three weeks for the third of ense. If, af er a third of ense, a pupil persists in uncontrollable conduct while riding a school bus, he/she shall be suspended from riding said bus for the

APPENDIX (A)

Legal Authority for Discipline in South Carolina:

The Code of Laws of South Carolina, 1976, Sect on 59-19-90, outlines the general powers and dut es of school trustees and states that the Board of Trustees shall also.... (3) Promulgate rules prescribing scholast c standards of achievement and standards of conduct and behavior that must be met by all pupils as a condit on to the right of such pupils to at end the public schools of such district. See, also, Opinions of the At orney General, Number 2051, page 134, 1965-66 as to authority of school superintendents to regulate discipline.

Title 59, Chapter 63, Art de 3, Discipline (Sect on 59-63-210, et seq., Code of Laws for South Carolina, 1976). Note: Under authority of state law, certain violat ons set forth in the Code of Student Conduct may lead to expulsion for the remainder of the school year or even to permanent expulsion.

h To establish the basic structure for promoting the health and welfare of the district's students by maintaining a safe, posit ve learning environment for students and teaching environment for staf that is free from harassment, int midat on or bullying.

The board prohibits acts of harassment, int midat on or bullying of a student by another student or students, staf or third part es that interfere with or disrupt a student's ability to learn and the school's responsibility to educate its students in a safe and orderly environment whether in a dassroom, on school premises, on a school bus or other school-related vehicle, at an of cial school bus stop, at a school-sponsored act vity or event, whether or not it is held on school premises, or at another program or funct on where the school is responsible for the student.

For purposes of this policy, harassment, int midat on or bullying is defined as a gesture, electronic communicat on or a writ en, verbal, physical or sexual act reasonably perceived to have the effect of either of the following:

- harming a student physically or emotionally or damaging a student's property, or placing a student in reasonable fear of personal harm or property damage
- insult ng or demeaning a student or group of students in such a manner as to cause substant al disrupt on in, or substant al interference with, the orderly operat on of the school

Any student who feels he/she has been subjected to harassment, int midat on or bullying is encouraged to f le a complaint with the principal or his/her designee in accordance with procedures established by the superintendent. Complaints will be invest gated promptly, thoroughly and confident ally. All school employees are required to report alleged violations of this policy to the principal or his/ her designee. Reports by students or employees may be made anonymously, but formal disciplinary С


